## **Risk Assessment**

## Introduction:

The value of pet 'therapy' is widely accepted as a powerful aid to stimulation and communication. Studies have shown that the presence of companion animals can improve the well-being of children and lower the rate of anxiety, simply by making the environment happier, more enjoyable and less forbidding. The team at Mayflower High School have been considering obtaining a dog as a school therapy pet for some time and the decision was made in October 2023 to go ahead with the project.

The rationale behind this decision was as follows:

- For the school to have a pet that was able to live as naturally as conditions would allow.
- For the animal to be properly cared for outside of the school day.
- To have a pet that the children could interact with and also be of benefit to the children's social and emotional development.

It is accepted that interacting with animals is not appropriate for all children but for some it has the potential to provide many positive benefits. Any parent who does **not** want their child to have direct interaction with the School Dog is invited to complete this <u>form</u>. The school dog will fully vaccinated as advised by the Vet and will have regular health checks. The insurance certificates will also be kept on site.

The risk assessment below is a working document and will be checked annually by key staff.

Visitors are advised that the dog is on the premises. Signage on entrance to MHS and in the area in which he is based to reinforce the message and remind visitors.
